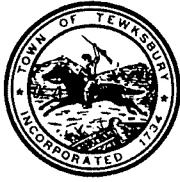

Dear Board of Selectmen,


