Re: Street Name: Naomi Way

Article 30 of the 2018 Annual Town Meeting placed the naming of streets, ways and projects under the jurisdiction of the Board of Selectmen. This was done in order to reduce confusion and enhance public safety.

On August 5, 2019, the Planning Board approved a special permit and subdivision to allow for a 2.69 acre lot to be split into 2 lots and the creation of a private way. Since that time, the developer has formally submitted to the Board of Selectmen for the name of the private way to be "Naomi Way".

I have received sign-offs from the Fire Chief, the Chief Assessor, Head Dispatcher and the Town Engineer. We all agreed that Naomi Way was an acceptable name for this private way.

We recommend that the Selectmen approve the name Naomi Way for this private way at 1420 Andover Street.
